FIELD TRIPS

The field trips are designed to complement a particular lecture in the lecture series and are held in the week following that lecture. Tickets for field trips are available only to lecture-series ticket-holders. Registration is limited by capacity of buses and places to be visited. *Each trip is offered on two dates—please indicate preferred date.* The cost of luncheons, ranging from \$1.50 to \$3.50, is not included in the tour price. Such costs will be collected on the day of the trip. There are no refunds on field-trip tickets. When possible, exchanges may be arranged with other subscribers at the lecture preceding each tour. A complete schedule and description of field trips will be mailed to all ticket-holders. In general, trip schedule is 8:45 A.M. to 4:00 P.M.

- Sept. 27 (Tues.)* Assemble at 64 East Lake Street at 8:45 A.M. in Room 201 for a slide lecture. A bus tour follows accompanied by guides from the Chicago Department of City Planning. The tour will start north passing the site of the proposed Marina Towers, the La Salle Street Redevelopment Area, to Old Town; then west to see the site of the Gateway Plan, the Near West Side Redevelopment Area, the Medical Center and a bus freight terminal; then east to Lake Meadows where a box lunch will be served in the new club building. After lunch there will be a visit to a model apartment in the new luxury building; then a visit to Convention Hall. The return to the Loop will be by way of the proposed sites for the University of Illinois and consolidated railroad terminal, down Dearborn Street to 64 East Lake Street, observing Central Area proposals.

Proceed by bus for tours of the following: Fourth Presbyterian Church, 120 East Chestnut Street; Temple Emanuel, 5959 Sheridan Road; St. Andrew's Greek Orthodox Church, 5649 Sheridan Road; Chicago Buddhist Church, 1151 West Leland Avenue. Luncheon (\$1.25) will be at Marillac House, 2820 West Jackson Boulevard, where there will be a tour and a talk. Return to 64 East Lake Street.
- Oct. 12 (Wed.)* *or*
Oct. 25 (Tues.) Assemble at 64 East Lake Street at 8:45 A.M. Proceed to Institute of Design at Illinois Institute of Technology where Arthur Siegel will lecture on photography as an art; 10:00 A.M.—10:30 A.M. a tour of the exhibits at the Institute of Design; 11:00 A.M.—12 noon, Morton Lecture Hall of Art Institute where there will be a panel discussion on Jazz in Chicago, Don Henahan, Classical Music Critic, *Chicago Daily News*; Eugene Lees, Editor of *Downbeat*; and Ramsey Lewis, Chicago Jazz Pianist; showing of Bertioia film; lunch, Arts Club (\$4.00). The group will then split to visit a few small galleries: Fairweather Hardin Galleries, Superior Street Gallery, Frumkin Gallery, Holland-Goldowsky Gallery; 2:30 P.M.—4:00 P.M. Second City to see a rehearsal, lunch fee includes refreshments at Second City—beer or coffee will be served. Return to 64 East Lake Street.
- Oct. 26 (Wed.)* *or*
Nov. 9 (Wed.) Assemble at 64 East Lake Street at 8:45 A.M. Proceed to East Chicago Avenue Police Station (35th Police District) for first-hand information on the operation of the Police Department on the district level. Proceed to 1104 South Wabash Avenue, Sixth Floor, Planning Section of the Police Department, followed by a visit to the Youth Bureau. Luncheon on your own at the Hilton, Blackstone, or any of the restaurants in the vicinity. Reassemble at 1:30 P.M. at the Central Police Building, 1121 South State, for a visit to the Communications Section which is the heart of modern police operations and which is being greatly expanded to meet present police needs. Return to 64 East Lake Street.
- Nov. 10 (Thurs.)* *or*
Nov. 17 (Thurs.) Assemble at 64 East Lake Street at 8:45 A.M. Proceed to Armour Research Foundation for guided tour including: Nuclear Reactor; Univac Computer and high speed data printer processing U.S. Census data; Acoustics Laboratories, including reverberation chamber and dead sound space; Building Materials Laboratories. Lunch on the Illinois Institute of Technology campus—\$2.00. The group will then proceed by bus to the University of Illinois Professional Colleges, West Side Medical Center, for tour including the Acro-Medical Laboratory (studies on man in space) and the new Medical Research Laboratory, modern facilities for work on research animals. Return to 64 East Lake Street.

UNIVERSITY COLLEGE is the adult educational branch of the University of Chicago. Its Downtown Center, now located at 64 East Lake Street, makes available to the intelligent, concerned adult in the Chicago area the intellectual resources of the University. It offers credit courses in more than forty fields and special non-credit programs of liberal and professional education. Among the latter are the Basic Program of Liberal Education for Adults, the Fine Arts Program, the Center for Programs in the Mass Media, the Center for Programs in Government Administration, the Office of Special Services to Business and Industry, and a series of Special Courses, including seminars, workshops, and tours. All these programs are described in detail in the new 1960-61 Annual Prospectus catalogue, which is available on request from the Downtown Center, 64 East Lake Street, Financial 6-8300.

THE WOMAN'S COLLEGE BOARD of Chicago, established in 1933, is a non-profit organization serving thirty liberal arts colleges and their local alumnae. It is a co-sponsor of the "Know Your Chicago" series, an associate member of the Chicago Educational Television Association, and a sponsor of radio programs by member colleges. The Fourth Educational Forum, open to the public, will be presented at the Morrison Hotel on Thursday, February 9, 1961. Other services include free college counseling for high school girls and publication of an Alumnae Club Guide and a Handbook of Information about member colleges. Admissions conferences are arranged with college representatives, and placement counseling is provided. Headquarters for all these services are in Room 1801, 30 North Michigan Avenue, ANdover 3-4981.
